This was probably due to the two fires at the same time in Tyler County and the posting of the burn ban.
- Education/Communications Committee: Charles Zimmerman reported on a TFA session that he attended where the main topic of interest was audits by the IRS. It was suggested that we should take pictures of work activities on our tree farms. An example would be repairing a fence. Also if called to an audit, take forest literature that was secured at various meeting that you attend. This shows that you are actively managing your tree farm and not engaged in a hobby. On another note, he informed us that the emerald ash borer infestation is closing in on Texas.
